CONTRACT FOR COOPERATION IN THE FRAMEWORK OF THE HOT DOG ZONE CONCEPT

hereinafter referred to as the RECIPIENT

whereby the SUPPLIER and the RECIPIENT are hereinafter jointly referred to as the PARTIES to the Agreement.

The company Hot Dog Zone Ltd. has developed a concept for implementation in retail sales points and other gastronomic points, a gastronomic zone under the name: Hot Dog Zone Concept. The aim of the Agreement is to obtain mutual benefits from the implementation of the Hot Dog Zone Concept project by the RECIPIENT.

Section 1

1. The SUPPLIER undertakes to cooperate with the RECIPIENT within the Hot Dog Zone Concept project and to provide the RECIPIENT with the following services through the company HOT DOG ZONE:
 - Delivery of equipment and accessories for the HOT DOG Zone indicated by the RECIPIENT, at wholesale prices,
 - Providing the RECIPIENT with a written manual, containing the necessary know-how to ensure quick and easy implementation of the Gastronomic Zone in the retail sales point.
2. The RECIPIENT undertakes to ensure the availability of HOT DOG ZONE products at their point of sale from the moment the HOT DOG ZONE CONCEPT is implemented.
3. The RECIPIENT will ensure such cooperation with the SUPPLIER as to provide their consumers with continuity and stability of HOT DOG ZONE product sales, in particular through timely payments and regular orders of products from the SUPPLIER, excluding any stock shortages.
4. Both PARTIES undertake to maintain confidentiality of this Agreement, which means that neither the RECIPIENT nor the SUPPLIER will disclose information regarding the details of the Agreement and its implementation to third PARTIES, in particular the substantive and organisational details of the HOT DOG ZONE CONCEPT.
5. The customer is obliged to keep the equipment and the entire Hot Dog Zone clean and to adapt the basic hygiene requirements and the requirements of the Food Standard Agency
6. The PARTIES undertake to exercise due diligence in the implementation of this Agreement, and in particular to strictly comply with its provisions and the provisions of the applicable law.
7. Any changes to the content of this Agreement require an annex in writing, under penalty of invalidity.
8. Matters not regulated by this Agreement shall be governed by the provisions of the Civil Code.
9. Any disputes arising in connection with the implementation of this Agreement shall be settled by the appropriate court having jurisdiction over the plaintiff's registered office.
10. This Agreement has been made in two identical copies, one for each party.



Section 2

1. The PARTIES are obliged to maintain confidentiality, which means that neither the RECIPIENT nor the SUPPLIER will disclose information regarding the details of this Agreement and its implementation to third PARTIES, and in particular any substantive information concerning the know-how related to the HOT DOG ZONE CONCEPT.
2. The RECIPIENT is obliged to keep confidential all substantive details, in particular marketing, organisational, implementation and training details related to the HOT DOG CONCEPT.
3. The RECIPIENT is not entitled to provide or in any other way transfer to its customers or other persons any substantive information concerning the know-how related to the HOT DOG CONCEPT in exchange for payment or in connection with any form of payment made to the RECIPIENT. In the event of termination of the contract, the RECIPIENT must not use any of the elements of the HOT DOG ZONE CONCEPT methodology for five years after its termination.
4. In the event of any breach of the above obligations - points 1-3, the party that violates the confidentiality shall pay the other party a contractual penalty of GBP 500,000 (five hundred British pounds) for each breach of confidentiality. The obligation to maintain confidentiality also applies to all legal or personal entities associated with the PARTIES to the Agreement, in particular spouses, descendants, ascendants, stepchildren, sons-in-law, siblings, stepfather, stepmother, parents-in-law, and entrepreneurs in any way associated with the RECIPIENT or SUPPLIER by economic relationships.
5. The obligation to maintain confidentiality applies to both PARTIES to the Agreement for the entire duration of the Agreement and for five years after its termination. The announcement of bankruptcy by any of the PARTIES does not release it from maintaining confidentiality within the deadlines specified above.



Section 3

Equipment Lease Agreement:

This Equipment Lease Agreement is made and entered into on the date of signing the contract between SUPPLIER and RECIPIENT.

Equipment: The SUPPLIER agrees to lease to the RECIPIENT the following equipment:

- 7 Rolls Roller Heater
- Single Contact Grill
- Marketing Package

Price: The SUPPLIER agrees to lease the Equipment to the RECIPIENT for the price of non-refundable £499.

Return on Investment: The SUPPLIER guarantees a return on investment within 3 months or your money back. The SUPPLIER's statistics show that the return on investment occurs after just 2 weeks with the sale of 25 hot dogs per day.

Ownership: After 3 months, the Equipment becomes the property of the RECIPIENT only if the RECIPIENT undertakes to continue cooperation with the Hot Dog Zone.

If the RECIPIENT decides to discontinue cooperation with the SUPPLIER after the initial 3 months, the SUPPLIER guarantees the refund of the deposit of £499. The SUPPLIER reserves the right to return the deposit only if all equipment is returned in working condition and without any mechanical damage.

Term: The term of this Agreement shall be 3 months, beginning on date of installation of Hot Dog Zone

Renewal: This Agreement may be renewed for an additional term upon mutual agreement of the PARTIES.

Termination: Either party may terminate this Agreement upon 30 days written notice to the other party.

Governing Law: This Agreement shall be governed by and construed in accordance with the laws of United Kingdom.



Section 4

1. The PARTIES undertake to exercise due diligence in the implementation of this agreement, particularly by strictly adhering to its provisions and to the provisions of the generally applicable law.
2. Any changes to the content of this Agreement require an annex in writing,
3. In matters not regulated by this Agreement, the provisions of the British Civil Law shall apply.
4. Any disputes arising in connection with the implementation of this agreement shall be resolved by the court competent for the registered office of the SUPPLIER.
5. This Agreement has been drawn up in two identical copies, one for each party.
